On thedate of signing the self-nomination form, the person desiring to serve on the Board must be an eligible elector of theDistrict. The form or letter must be filed no earlier than January 1 and no later than the sixty- seventh (67 <sup>th</sup> ) day beforethe date of the next regular special district election. The form is filed with the Designated Election Official, or if nonehas been designated, the presiding officer or the secretary of the District at the address above. This form may be obtainedby contacting the District's Administrative Coordinator at (720) 213-6621. In place of the form, the candidate may submita letter signed by the candidate and a registered elector of the state as witness to the signature of the candidate. Both theform and letter must state the following information: (1) name of the special district; (2) director office sought; (3) termof office sought; (4) date of the election; (5) full name of the candidate as it is to appear on the ballot; and (6) whetherthe candidate is a member of an executive board of a unit owners' association, as defined in §38-33.3-103, C.R.S., locatedwithin the boundaries of the District.
